Delivery to Desco



Upon arrival the materials are weighed before being off-loaded and separated into predefined waste streams.



Separation into waste streams



The materials are unpacked and sorted into waste streams for further processing and dismantling.



Dismantling



Here items are dismantled into fractions of E-Waste: PC Boards, Plastics, Ferrous & non-Ferrous Metals, Glass and PVC Cabling.



Processing Shredding



All PC Boards are shredded before being sent to a refinery for smelting.



Refinement



All fractions of E-Waste are shipped to specialist downstream vendors for final recycling and recovery of secondary resource materials.




